Ensure that all participants warm up and down appropriately for the level and duration of training- in classes and workshops this is the tutor's responsibility. The tutor should check whether participants have any injuries or illness that might prevent them from attempting a particular skill. The tutor should only teach skills that they think are safe for the participant to learn, taking into account their age, height, weight, strength, fitness, illness and injury, physical and mental ability in so far as these can be assessed. Tutors should spot participants attempting skills with risk involved, in order to reduce the likelihood and the severity of injury should the participant not manage the skill.	3	2	6

Remote	Unlikely to occur
Improbable	Occurrence is extremely unlikely

#### **Severity**

Multi fatality	Self explanatory
Fatality	Self explanatory
Major injury	Reportable incident under RIDDOR such as fracture of bones, dislocation, amputation, occupational diseases (e.g. asthma, dermatitis), loss of sight.
Minor injury	First aid administered. This would include minor, cuts, bruising, abrasions and strains or sprains of ligaments, tendons, muscles
Negligible impact	Self explanatory
